### 2223-126 PRECEPT / BUDGET 2023/24

The Clerk circulated a copy of a proposed budget and precept allocation based on not increasing the cost to a Band D property. ESBC had provided the tax base figures for the parish and advised that the tax support scheme grant of £5813 is to be passed on again for 2023/24. These have formed and been included the budget presented.

It was proposed by Cllr Goode to accept the budget and precept requirement of £202119.62 for 2023/24 which is an increase of £1393.62 to the allocation but a nil increase to the amount to be recovered from parishioners.

The proposal was seconded by Cllr Pritchard with all present in favour.
