


Stretton Parish Council Agenda

The question should be directed to the Chair of the meeting.- Present a petition to the Chair of the meeting with at least 10 signatures of local government electors living in the Parish of Stretton, about any question on which the Parish Council has power. <p>The Chair may answer orally, may undertake to provide a written reply within 7 days or may decline to answer or defer the discussion until the next meeting of the Parish Council.</p> <p>This agenda item is limited to 15 minutes.</p>
